ABSTRACT

SD Kristen Kanaan is one of the biggest among Christian elementary schools in Banjarmasin. The decision of the school to opt for online learning as the educational method has proven to be the key of effectivity. This research seeks to display an empirical data as a proof that the effectivity of online Christian education in that school is predominantly determined by the online learning platform that they are using. This paper uses neuro-research as the research method and simple random sampling as the data collection technique. The respondents involve 212 students, and the research instrument is Likert-scale questionnaire with range of 1 to 5 point. The instrument calibration is orthogonal iteration. This article will be written in this following sequence: first, it will deal with the importance of learning media or platform in conducting Christian education; second, it will deal with presenting the empirical data of the effectivity of online Christian education in SD Kristen Kanaan Banjarmasin; and third, conclude.

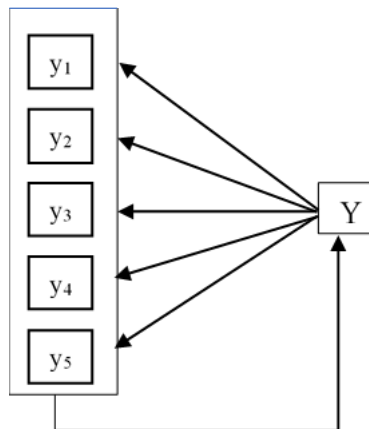

3.1. The Importance of Learning Platform

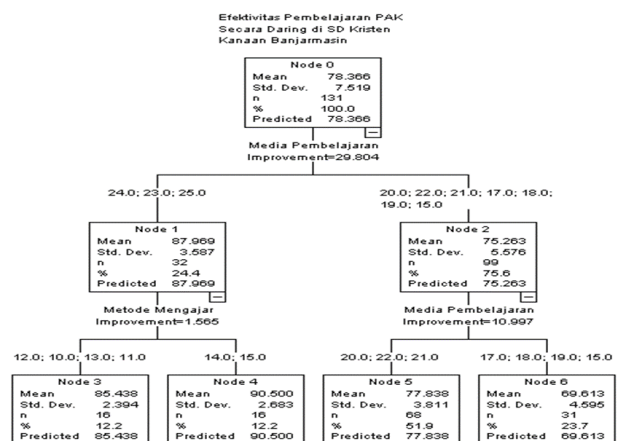

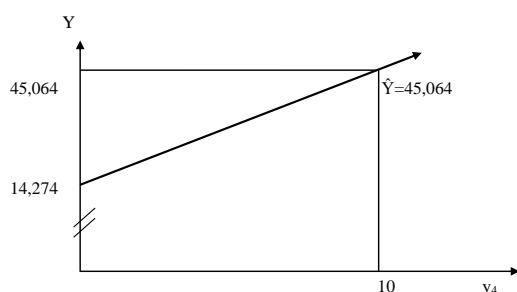

It means if Effectivity Online Christian Education be increased by Indicator Media online learning with 10 "treatment", so Effectivity Online Christian Education will be increased 30,79 times from the current condition.



4. CONCLUSION

While the quality and pedagogical effectivity of distance education is now being more acknowledged, the online learning platform has proved to be one of the most

decisive factors of such effectivity. That is also the case for SD Kristen Kanaan Banjarmasin as it is proven by the empirical data above.

The result of the research shows empirically that the students of SD Kristen Kanaan Banjarmasin has shown a medium effectivity when conducting education through online learning platform; and second, the most determining factor that generates such an effectivity of online Christian education in SD Kristen Kanaan Banjarmasin is the learning platform that they use.
